9. PRESSURES ON THE REQUESTERS OF FREE ACCESS TO INFORMATION

Adoption of the Law on Free Access to Information represents the base for establishment of different relations between the state and the citizens, for the citizens finally obtain a mechanism for direct control of the state institutions work.

This "small revolution" came across resistance of particular structures of the system, especially those whose work has so far been covered by a veil of secrecy, which certainly does not contribute to stimulate citizens to use the rights guaranteed by the law.

Any form of direct or indirect influence on the requester represents a limitation of the right to free access to information.

Case study 14: Letter of the Director of the Agency for National Security

During monitoring of the law implementation, MANS encountered various forms of pressures by numerous institutions which were not ready to answer the requests for information, and the most drastic example is certainly the relationship of the Agency for National Security (ANB).

Verdicts of the Administrative Court passed in favour of MANS, annulled decisions of ANB by which information on the number of employees of that institution and the number of wiretaped and followed persons during 2005 were proclaimed state secrets.

After publishing of the verdicts in the media, the Director of ANB on 18 October 2006 sent a letter to the home address of the Executive Director of MANS, in which he expresses his discontent with the appearing in public of MANS.

In the letter of the Director of ANB it is stated among other that the media appearances of MANS on the relationship between the citizens and ANB "could be interpreted by a part of the public in a malicious and tendentious manner", and that "our efforts to bring into question the trust which the citizens of Montenegro have in the work and professional quality of the Agency for National Security have no grounds"

After that, in an open letter addressed to the Presidents of the State, the Parliament and the Government, MANS asked them to prevent the threatening of privacy, attempt to narrow the basic human rights and put pressures on the citizens of Montenegro by the ANB become a rule.

No reply to the open letter was ever received, and the Head of the Cabinet of the Director of ANB apologized in public stating that the letter they had sent was the result of an administrative mistake.


