## INTRODUCTION

This report is produced within the framework of the project implemented by six nongovernmental organisations: the Network for the Affirmation of the Nongovernmental Sector (MANS), the Safe Home for Women, Mogul, Stečajci u Crnoj Gori (Workers from Bankrupt Companies in Montenegro), Breznica, and the Youth Association of Montenegro.

The section led by the Youth Association dealt with availability of information held by the university units in Montenegro regarding the transparency of their funding, students' rights and possibility of their exercise under the Bologna Principles.

Special attention was devoted to the national employment strategy for persons holding university degrees and the activities undertaken by the responsible institutions in addressing the increasingly more pressing problem of unemployment among the graduate students. The Youth Association, with the legal support by MANS, used all the available means of administrative procedure in order to obtain the relevant information.

The first part of the report deals with the transparency of the state- and privately funded universities, and the faculties within their composition. The second part summarizes the statistical information on the implementation of the Free Access to Information Law (FAI Law) by 47 institutions directly or indirectly involved in higher education and students' rights. The third part gives some conclusions and recommendations to improve transparency of higher education institutions.

## 1. TRANSPARENCY OF HIGHER EDUCATION INSTITUTIONS

### 1.1. University of Montenegro

Aiming to check the level of transparency of the University of Montenegro (UoM), over 60 requests for information were filed with this institution. The information requested concerns, among other things, the UoM's admissions policy, the relation to students and their rights, the research and scientific activities, with the special focus on spending of budgetary appropriations for higher education but also funding through fee-paying students and the distribution of such funding.

**The University of Montenegro responded to all requests, providing full or partial information per one in three requests filed.**

Particularly interesting is the fact that the UoM does not hold the data on the operation of its individual organizational units, especially as regards spending of budgetary allocations and income from fee-paying students. Thus, the UoM holds no records of the amounts paid during the academic year 2012-2013 on the account of housing loans and travel cost reimbursement for professors, salaries for visiting professors, nor the amounts spent on research projects.

On the other hand, the UoM posted its financial statements on its web pages.

### 1.2. UoM's organizational units

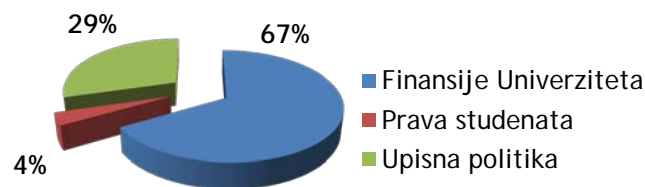
Most faculties making part of the University of Montenegro are in breach of the FAI Law. Over 150 requests for information were filed with these faculty units, and **somewhat over half of them were responded to.**

The university units particularly problematic regarding their transparency are the following: the Electrical Engineering Faculty, the Mechanical Engineering Faculty, the Faculty of Metallurgy and Technology, the Civil Engineering Faculty, the Faculty for Sport and Physical Culture - Nikšić and the Faculty of Pharmacy. They failed to respond to most of the requests, even after the appeals were lodged.

Unlike the above the Faculty of Biotechnology, the Faculty of Economy, the Faculty of Dramatic Arts, the Faculty of Arts, the Faculty of Political Sciences, the Faculty of Medicine and the Faculty of Law, responded within the statutory timeframe to the majority of requests.

**The faculties were least ready to submit the data on funding and admissions policy, and thus most often failed to respond to such requests.**

On average, most of the information received in due time concerned the exercise of student rights under the Bologna principles.

### 1.3. Privately funded universities and faculties

The Youth Association attempted to obtain information from privately funded universities and faculties in order to have a more comprehensive picture of the higher education status in Montenegro.

Although privately funded institutions are not obliged to submit information under the FAI Law, we hoped they might respect the public interest to receive information regarding higher education.

Nevertheless, privately funded universities and faculties largely ignored the requests for information, some of them informing us of the absence of their obligation to publish information regarding their operation and funding.

## 2. STATISTICS ON ACCESS TO INFORMATION

In 2013, our organisation filed over 400 requests for information with 47 university units in Montenegro, with ministries and other state authorities responsible for higher education sector. The requested information predominantly referred to university funding, students' rights and their employability after graduation.

The statistics show that it was possible to obtain only somewhat over one half of the requested information through the first and second instance procedure.

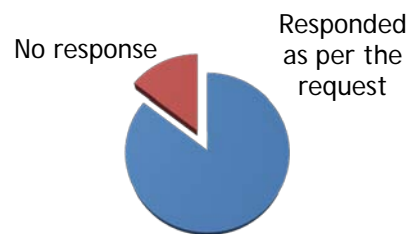
The table below gives more details as regards the responses by institutions, and per appeals and urgencies.

### 2.1. First instance procedure

The FAI Law envisages that all information of public interest needs to be accessible to the requestor in a summary procedure. Notwithstanding the indubitable public interest for information on higher education, as a pillar for the future development of the country, to be made available to all interested parties, **higher education institutions failed to respond to one in six requests for information.**

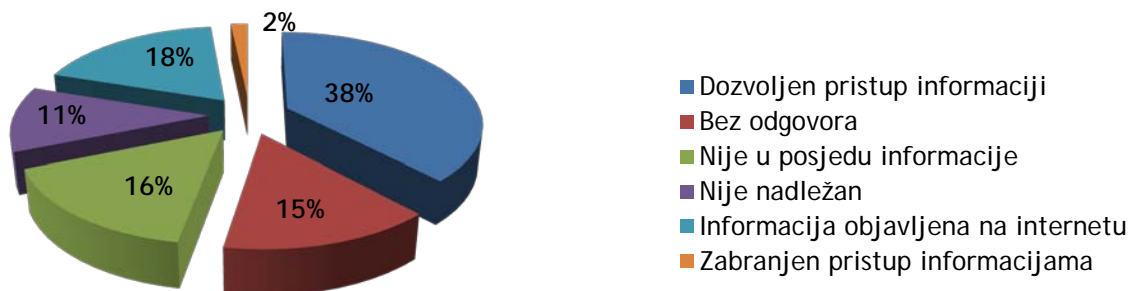


Graph 2: Responding per requests

The institutions made the documents available, fully or partially, to one in three requests. In 27% of cases we were informed that the institutions did not hold the information requested or that it was not within their scope of competences to provide such information. Only three institutions believed some of the information they held to be classified, and invoked the limitations for accessing information as stipulated by the Law.<sup>1</sup>

Not more than 18% of all information requested was proactively posted on the web. This is quite disconcerting given that students and the young are the target group which in the greatest share uses electronic communication means.

## 2.2. Second instance procedure

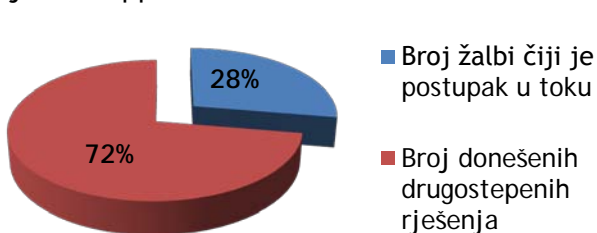
The institutions failed to respond in a timely fashion or were otherwise in breach of the FAI Law in more than one half of all cases. This prompted us to launch second instance procedures and we filed over 200 appeals to the Agency for Protection of Personal Data and Free Access to Information.

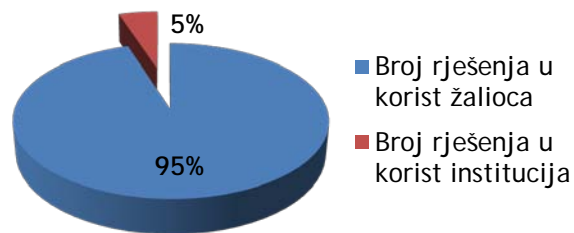

The Agency or the first instance bodies themselves<sup>2</sup>, until the time of this report, decided in somewhat over 70% of cases, with 60 appellate procedures still pending.

As regards the decision per appeals, over 95% of them are in our favour, with only eight rejected appeals.

### 3. CONCLUSIONS AND RECOMMENDATIONS

The exercise of the right to have access to the information held by institutions responsible for higher education is uneven and mostly lacks transparency. In most of the cases, the requests for information are dealt with in the second instance, with silence of administration and breach of deadlines being very pronounced problems.

Institutions fail to publish information proactively, with only 18% of the information requested within this project being already in the public domain available online.

The privately funded universities refuse to divulge information even as per requests; hence, the general public does not have an understanding of how such institutions are organized or funded or about the quality of education they offer.

Given the above, the Youth Association proposes the following:

- **Additional personal development and training of officers responsible for responding to information requests** is needed in majority of higher education institutions, in order for all the interested parties to receive in due time the verified and accurate information regarding higher education, funding and admissions policy.
- **Proactive provision of information** is at a very low level; hence the plan for publication and regular update of information available on web pages of universities and faculties is needed.
- There should be a **statutory requirement for all academic institutions, regardless of the source of funding, to publish and submit to interested parties information of general interest.**
