STUDY CASE: RENCONSTRUCTION OF COMMUNITY CENTRE IN PLJEVLJA



I: INTRODUCTION

Reconstruction of the Community Center in Pljevlja started in 2007 and was funded from the budget of the Municipality of Pljevlja and the capital budget of Montenegro. Within a seven-year period, i.e. from 2007 to 2013, at least 27 public bids concerning reconstruction and renovation of the Community Centre were invited. For these purposes €3.7 million was spent, not including 2008 for which MANS does not have official data.

In 2014, an additional sum of €1.5 million was planned for the continuation of the works, but by

the end of the year there was no end in sight of the works.

The case study will prove that the suspicion concerning an abuse of official position by the officials in the municipality of Pljevlja is founded. It refers to creating jobs regarding the reconstruction works on the basis of public procurement by giving preference to certain contractors, concluding agreements on performing construction works far beyond the determined public procurement values, whereas the cost of the agreed works accrued by subsequent signing of annexes to the agreements, which caused the municipality to lose hundreds of thousands of euros. The study examines several major public procurements concerning the reconstruction of the Community Centre in Pljevlja.

II: COMPANY "VING" HAS ITS FIRST ENGAGAMENT IN 2007: During years-long reconstruction of the Community Centre in Pljevlja, most of the works were entrusted to the Pljevlja-based company "Ving", which did not meet agreed obligations. In spite of this, the Municipality of Pljevlja continued cooperation with it over the course of years.

In that sense, the first in a series of tenders regarding the reconstruction of the Community Centre was invited early in May 2007.¹ According to the tender, external works on the building were estimated at €400,000, which was the sum envisaged in the Plan for Public Procurement for that year.² Two tenders were submitted, one by the company "Lipa" offering €593,000, wheras the company "Ving" offered to perform the works for €629,000.³

The Municipality of Pljevlja selected as the most financially sustainable the offer submitted by the company "Ving", which was to carry out the works for €629,000, what would be €230,000 more than the estimated value of the public procurement. Though the municipality could legally reject the public procurement⁵, it engaged the company "Ving", although the annual Plan for Public Procurement envisaged only €400,000 for this particular procurement.

The contract with "Ving" was concluded in June 2007, giving four months for completion of works, where the contractor had to commence the works within 10 days from the day of signing of the agreement. 6 Interestingly, the selected contractor was paid €200,000 in advance, 7 although the advance payment was not in accordance with the tender, nor the agreement concluded. The agreement no termination clause.

The company "Ving" entered the business in July 2007.8 During the next two years, instead of completing the works within the time limit, the Municipality of Pljevlja signed a series of annexes to the agreement, thus increasing the value of the original agreement for additional €152,000 on the grounds of subsequent works.⁹ This means that the total cost of the performed works surpassed the staggering sum of €780,000, i.e. the job cost almost twice the money originally laid down in the tender. 10


III: WORKS FROM 2008 AND 2009 ALLOCATED TO "VING"

In March 2008, the Municipality of Pljevlja allocated a new to "Ving" – a plumbing job estimated at about €115,000¹¹ at the Cultural Center, although it was estimated at €105,000¹² in the public tender. This contract had no termination clauses either, while the determined penalties for each day of exceeding the agreed time limit of the work were 0.3 per cent of the contract value, whereas they were not allowed to exceed three per cent of the total contract value. This did not comply with the public tender, where the penalties were determined to be 0.5 per cent, i.e. it was not allowed to exceed five per cent of the total contract value.

In March 2009, when the Public Works Directorate in the Municipality of Pljevlja published a tender for final works on the reconstruction of the Community Centre, the value of the works was estimated at the sum of €1 million.¹³ These works were also assigned to "Ving" for the sum that was higher by one third, i.e. its offer of €1,365,096 was accepted as the most favorable, with an advance of 30 per cent, which was not stipulated in the tender documents, whereas the fivemonth time limit for completion was envisaged.

Namely, the Public Works Directorate sent an official letter¹⁴ to the Mayor of the Municipality of Pljevlja seeking the approval to exceed the originally estimated value of the public procurement. The approval was granted the following day¹⁵ on the grounds that the funds for the works were provided from the municipal budget for 2009, with a sum of exactly €1 million. So, even though there was a legal possibility to annul the tender process, it was not done in this case, which was directly at the expense of the Municipality of Pljevlja.

The contract with "Ving" was concluded in October 2009, ¹⁶ four months after the selection of the most favorable bid. A month later, a €440,000 worth contract on co-financing the final work on the reconstruction of the Community Centre in Pljevlja was signed between the Ministry of Culture, the Public Works Directorate and the Municipality of Pljevlja. ¹⁷ However, an annex to the contract was signed in December thus raising the sum to €700,000. ¹⁸ The Ministry and the

The Municipality of Pljevlja concluded a series of assignment agreements with the company "Ving", transferring financial claims from the Public Works Directorate. In the period from August 2010 to December 2011 the Pljevlja-based company ceased a total of €665,000 for the performed works.¹¹ Moreover, "Ving" was also late with the completion of the works. Only two years after the signing of the contract the works were completed, even though the deadline for the completion was four months.²¹ Available data indicate that the Municipality has not incurred penalties for the delay.²¹

IV: CONTROVERSIAL CONTRACTS WITH "TEHNO-GRADNJA"

In July 2010 the Municipality of Pljevlja invited a tender²² for constructing and installing stage lightning and audio and video system in the municipal auditorium of the Communal Centre, estimating the value of the works at €290,000.²³ The work was allocated to the Pljevlja-based company "Tehno-gradnja"²⁴, with a contract worth more than €313,000 signed the same year in August.²⁵ Not only the value of the contract was higher but it did not contain a termination clause.

Two years later, through a negotiation process, ²⁶ this company was hired again regarding installing audio and video stage lighting in the Community Centre building. Namely, late in 2011, the Municipality of Pljevlja was given a permission to open negotiations on selecting the most favorable tenderer, after receiving not a single acceptable offer during the tender procedure. By a process of negotiation, the work was allocated to the company "Tehno-gradnja," based on the contract worth €663,000²⁷ and signed in May 2012, even though it did not meet all requirements, i.e. it did not have one of the necessary licenses, but submitted as an evidence the decision "that it fulfills the requirements for obtaining the license."²⁸

Controversial contarcts with company "Tehno-gradnja"

Contrary to the public tender, the contract concluded with "Tehno-gradnja" set out that the Municipality would pay advance nearly half a million euro in advance to the designated contractor, even though the company had stated in the offer that it would demand claims only 15 days after the completion of the works. According to the available data, the works envisaged in the contract did not commence at the beginning of 2014.²⁹

V: DOZENS OF PUBLIC TENDERS FOR SIX YEARS

In the period between 2007 and 2012 the Municipality of Pljevlja invited at least 10 lower values public tenders for furnishing, decorating or reconstruction of the Community Center in Pljevlja. The prices of the allocated works were higher than the estimated values of the public procurements, or annexes to the contract were subsequently concluded with selected tenderers by which the basic price of the works was increased.³⁰

The available data show that the estimated value of the 10 public tenders was €356,000, while the agreed value, including the subsequent increase in the basic price, was €405,059, which is €49,000 more than originally determined. On the basis of these 10 tenders, the company "Ving" was allocated four jobs at the price of €136,000.

Moreover, in the period from 2008 to 2012 the Municipality of Pljevlja put in 11 requests for submitting offers using a shopping method for furnishing and adaptation, as well as electrical and engineering works at the Community Center in Pljevlja.³¹ The total value of procurements under shopping amounted to €165,500, and the works had a total value of €182,247, out of which the works allocated to "Ving" amounted to over €158,000.

VI: RECONSTRUCTION OF COMMUNITY CENTER FROM THE BUDGET OF THE MUNICIPALITY OF

For the purpose of reconstructing the Community Center, a sum of €500,000 was allocated from the budget of the Municipality of Pljevlja for 2007, whereas €611,000 was realized.³² A budget of €650,000 was allocated for this project for the year³³ 2008, but MANS does not have information on the money spent.

The budget plan for 2009 envisaged a sum of €700,000, whereas €886,000 was spent.³⁴ During 2010, €589,000 was planned to be invested, while €767,000 was allocated for this purpose.³⁵ The budget plan for 2011 envisaged €1.2 million, whereas €861,000 was invested.³⁶ The 2012 budget projected investing €642,000, whereas €582,000 was actually

invested.³⁷ The budget plan for 2013 projected the amount of €320,000 for reconstruction of Community Center, while only €50,000 was invested.³⁸ Finally, the budget plan for 2014 projected the sum of €1.5 million for the completion of the works.³⁹
