


NGO MANS sent a request to allow our representative to take part at the session of the Parliamentary Committee where the candidates for the Supreme State **Prosecutor (SSP) will be heard.** Bearing in mind that in the past 20 years, MANS has discovered and reported more cases of high corruption and organized crime to the State **Prosecutor's Office than all state institutions combined, we believe that we can point out** significant aspects of the work of the Supreme State Prosecutor's Office, regarding which it is important to get statements from the candidates.

A months-long investigation conducted by MANS into the assets and income of retired NSA and Police Directorate officer, Duško Golubović, showed that his family spent over one million euros for the purchase of several properties and luxury vehicles over a ten-year period. - Three years after the change of government, why are the NGOs still the ones dealing with people like Duško Golubović instead of competent institutions?
- Will a new Supreme State Prosecutor be elected, what are the advantages and disadvantages of the candidates?

Data from Transparency International's report on the Corruption Perceptions Index (CPI) for the previous year show that Montenegro improved its position by one point compared to 2022.

This year's ranking of Montenegro represents a minimal improvement compared to the previous year and does not significantly extend beyond the limits of what was the corruption perceptions index before the dismissal of the long-term government. This confirms that the state capture system has far-reaching and lasting consequences, but also that there is still not enough political momentum among the <u>new government</u> officials to deliver significant and sustainable results in the fight against corruption. 30/01/2024


